COMMENTS:

The reason that Section **C: Subtotal Intake from Incoming Transfers from Orgs within Community/Coalition** is not equal to Section **J: Total Outgoing Transfers to Orgs with Community/Coalition** is that each of the 3 agencies in the current coalition had defined the "orgs within community" differently. That would mean that transfer counts include more than the 3 agencies involved in this application process. The "coalition" was not officially defined until starting the grant application process with Maddie's Fund, whereas the statistics for 2006 and 2007 were collected prior to this decision.

I agree that in completing this form, we have used the Maddie's Fund definitions of "Healthy," "Treatable - Manageable," "Treatable - Rehabilitatable," and "Unhealthy & Untreatable" as set forth in the attached document titled, "Maddie's Fund® Categorizations/Definitions of Shelter Animals."
